WHEREAS, Councilor Lathrop introduced proposed Local Law No. B-2010, to impose a moratorium on hydraulic fracturing and/or hydrofracking in the Town of Marcellus, and made the following motion, which was seconded by Councilor Sheridan; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Marcellus, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of

said Local Law, with the result that the Town Board shall act as lead agency in this matter.

NOW, THEREFORE, BE IT RESOLVED, that this Board shall act as lead agency, the enactment of proposed Local Law No. B-2010 is Type II action and therefore will have no significant effect on the environment, thus concluding environmental review under SEQR; and it is further

RESOLVED, that the Town Board conduct a public hearing as to the enactment of proposed Local Law No. B-2010 at the Town Hall located at 24 East Main Street in the Town of Marcellus on September 13, 2010 at 7:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard.
