August 12, 2013

### **OLD BUSINESS:**

Supervisor Ross suggested that Mr. Hakes and Mr. Scanlon set up interviews with the two candidates for the vacancy on the Assessment Review Board. We had two people interested in the position, Mr. Montgomery and Mr. Coville. Once they have the interviews set up, they will contact the Board Members to inform them of the date and time for their availability.

### **NEW BUSINESS:**

<u>Diane DeBottis – Noise in Light Industrial Zone:</u> Ms. DeBottis stated that on July 18, 2013, the Ultimate Goal had set off fireworks. She is very concerned about the lack of safety, the parking on Route 174 and around the curve onto Masters Road. There was no traffic control on these roads; cars were parked on both sides of the roads. People were standing near the road and in between cars.

Barbara Hughes also stated that the fireworks were being set off into the crowd. Ms. Hughes stated that the Fire Department was not aware that the Ultimate Goal was going to have a Fire Works display that evening.

John Houser has spoken with people at the Ultimate Goal and he will go for a test run before they have another Fireworks Display.

John Scanlon asked if the main concerns from Ms. DeBottis and Ms. Hughes are:

- a. Notify The Fire Department
- b. Have people controlling the traffic
- c. Have John Houser come by and do a test run before the actual display
- d. Post a sign outside the Ultimate Goal when they are having a Fireworks Display to let the neighbors and people in the area know

Ms. Debottis and Ms. Hughes both stated that any help would be appreciated.

Councilor Scanlon thanked Ms. DeBottis and Ms Hughes for bringing this matter to the Town Board's attention.

### Pass Local Law 2-2013 "Amending the Town of Marcellus Zoning Law of 2009:

Supervisor Ross read the resolution from the Onondaga County Planning Board regarding Local Law 2-2103. The Onondaga Planning Board has determined that said referral will have no significant adverse inter-community or county-wide implications and may consequently be acted on solely by the referring board.

### TOWN BOARD RESOLUTION

### August 12, 2013

The following resolution was offered by Councilor Hakes, who moved its adoption, seconded by Councilor Scanlon to wit:

WHEREAS, proposed Local Law No. 2-2013, titled "A Local Law Amending the Town of Marcellus Zoning Law As Enacted by Local Law No. 6-2009, titled 'Town of Marcellus Zoning Law of 2009', as Heretofore Amended by Establishing Cemeteries as a Permitted Use in Certain Zoning Districts Within the Town," was presented and introduced at a regular meeting of the Town Board of the Town of Marcellus held on June 10, 2013; and

**WHEREAS**, proposed Local Law No. 2-2013 will have the effect of allowing cemeteries as a permitted use, subject to certain additional requirements, in the following zones within the Town: R-1 Residential Zone; R-2 Residential Zone; R-3 Residential Zone; and A-1 Agriculture Zone.

WHEREAS, a public hearing was held on proposed Local Law No. 2-2013 on the 8th day of July, 2013 by the Town Board of the Town of Marcellus and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Marcellus in its final form in the manner required by Section 20 of the Municipal Home Rule Law of the State of New York; and

**WHEREAS**, notice of the public hearing on proposed Local Law No. 2-2013 was also given to all adjoining municipalities and they were given a full and fair opportunity to be heard at said public hearing on July 8, 2013; and

WHEREAS, it was determined on June 10, 2013 that no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Marcellus, such that there are no other involved agencies within the meaning of the State Environmental Quality Review Act (SEQRA) with respect to the proposed adoption of said proposed Local Law No. 2-2013, with the result that the Town Board assumed lead agency status in this matter; and

**WHEREAS**, it was determined on June 10, 2013 that the adoption of said proposed Local Law No. 2-2013 is a Type I action for purposes of environmental review under the SEQRA; and

**WHEREAS**, the SEQRA process for this action was completed by this Board at its July 8, 2013, meeting, this Board, having determined the enactment of said proposed Local Law No. 2-2013 would not have a significant adverse effect on the environment and therefore a Negative Declaration was adopted for purposes of SEQRA; and

WHEREAS as required by General Municipal Law, Section 239, this Local Law was referred to the Onondaga County Planning Agency and that Agency at its meeting held on July 24, 2013 determined that the proposed legislation will have no significant adverse inter-community or county-wide implications and may consequently be acted on solely by the referring Board, and

**WHEREAS**, it is the determination of this Board that it is in the public interest to enact said Proposed Local Law No. 2-2013.

### **NOW, THEREFORE**, it is

**RESOLVED AND DETERMINED**, that the Town Board of the Town of Marcellus, Onondaga County, New York, does hereby enact proposed Local Law No. 2-2013 as Local Law No. 2 of 2013 as follows:

### TOWN OF MARCELLUS LOCAL LAW NO. 2-2013

A LOCAL LAW AMENDING THE TOWN OF MARCELLUS ZONING LAW AS ENACTED BY LOCAL LAW NO. 4-2009, TITLED "TOWN OF MARCELLUS ZONING LAW OF 2009", AS HERETOFORE AMENDED BY ESTABLISHING CEMETERIES AS A PERMITTED USE IN CERTAIN ZONING DISTRICTS WITHIN THE TOWN.

**BE IT ENACTED** by the Town of Marcellus acting through its duly constituted Town Board that this Local Law amends the "Town of Marcellus Zoning Law of 2009," enacted by Local Law No. 4-2009 (hereinafter the "Town of Marcellus Zoning Law"), as follows:

# Section 1. Amendments to Section 4, titled "Definitions", of the Town of Marcellus Zoning Law.

Section 4, titled "DEFINITIONS", of the Town of Marcellus Zoning Law is hereby amended so as to insert the following new definition of "CEMETERY" therein.

"CEMETERY shall mean land, place, structure, facility, building or any portion thereof improved and maintained for the interment of human remains and may include interment structures, such as mausoleums, administrative and maintenance structures and facilities for conducting funeral services, but excludes facilities for the cremation of human remains."

## Section 2. Amendments to Section 7, titled "R-1 Residential Zone", of the Town of Marcellus Zoning Law.

Section 7, titled "R-1 RESIDENTIAL ZONE", and of the Town of Marcellus Zoning Law is hereby amended so that a new subparagraph "A.6. k) is added as follows:

- "k) Cemetery. On a lot of 5 acres or more provided that:
- 1. Notwithstanding Sec. 26, A.2., such cemetery shall be subject to site plan review and approval consistent with the provisions of Sec. 26.
- 2. No burial or memorial plats or buildings shall be closer than 25 feet to any residential lot line.
- 3. All burials shall be undertaken in strict accordance with applicable regulations of the New York State Department of State and Department of Health."

# Section 3. Amendments to Section 12, titled "B-1 Business Zone", of the Town of Marcellus Zoning Law.

Section 12, titled "B-1 BUSINESS ZONE", of the Town of Marcellus Zoning Law is hereby amended to delete Paragraph "A", subsection "1." in its entirety and replace it as follows:

"1. All principal uses permitted in R-1 zone, except for new one-family dwellings and cemeteries, subject to the same requirements as specified, with the exception of the minimum 5-acre requirement for Day Care Centers, Care Homes, and Medical Facilities."

## Section 4. Amendments to Section 13, titled "L-1 Light Industry Zone", of the Town of Marcellus Zoning Law.

Section 13, titled "L-1 Light Industry Zone", of the Town of Marcellus Zoning Law is hereby amended to delete Paragraph "A", subsection "1." in its entirety and replace it as follows:

"1. All principal uses permitted in R-1 and A-1 zones, except for one and two-family dwellings and cemeteries, subject to the same requirements as specified."

### Section 5. Severability.

If any word, phrase, sentence, part, section, subsection, or other portion of this Local Law, or the application thereof to any person or to any circumstance, is adjudged or declared invalid or unenforceable by a court or other tribunal of competent jurisdiction, then, and in such event, such judgment or declaration shall be confined in its interpretation and operation only to the provision of this Local Law that is directly in controversy in which such judgment or declaration is rendered, and such judgment or declaration of invalidity or unenforceability shall not affect or impair the validity or enforceability of the remainder of this Local Law or the application hereof to any other persons or circumstances. If necessary as to such person or circumstances, such invalid or unenforceable provision shall be and be deemed severed herefrom, and the Town Board of the Town hereby declares that it would have enacted this Local Law, or the remainder thereof, even if, as to particular provisions and persons or circumstances, a portion is severed or declared invalid or unenforceable.

### Section 6. Effective Date.

This Local Law shall take effect upon its filing with the New York Secretary of State.

Set Date for Fall Trash Days: A motion was made by Councilor O'Hara to set the Fall Trash Days for Fridays Sept. 27 and October 4, 2013 from 12:00 noon to 3:00 pm; and Saturdays, Sept. 28 and October 5, 2013 from 8:00 am – 12:00 noon. Councilor Lathrop asked if this involves any overtime on Fridays. Saturdays is always overtime. Don MacLachlan, Highway Superintendent, will work it out so that the Fridays won't count as overtime. Councilor O'Hara suggested that they could work until 12:00 on Thursday and come back in on Friday for the 12:00 – 3:00 pm shift. The motion to set the dates and times for the Fall Trash Days was seconded by Councilor Scanlon.

Authorize bids for Exterior Lighting Project: A motion was made by Councilor Scanlon to authorize the Town to receive bids for the Exterior Lighting Project. Councilor Lathrop asked why we are putting more money in this obsolete building. Supervisor Ross explained that this is grant money from JCAP. This is only a motion to authorize the Town to receive bids for the Project. Councilor Hakes seconded this motion.

**End of Year Report:** Councilor O'Hara stated that the Councilor's received a letter from the Comptrollers Office stating that the 2012 report filed with NY State. Tracie Barnes, the Accountant, stated that she is working on it. She has been in touch with the Comptroller's Office every few months and continues to work on it. She cannot send in the 2012 report until the 2010 and 2011 reports are done. The auditors are coming tomorrow to start auditing the Limeledge Water District bills. The Board Members would like to help out in any way they can. Tracie would like to come to a Workshop Meeting to discuss this matter in more detail.

Skaneateles Labor Day Race: A request was made from Dick Searing, Assistant Race Director for the Skaneateles Labor Day Race, for the approval from the Town Supervisor to hold the Coon Hill Grind bike race at the Skaneateles Ski Club which lies in the Town of Marcellus. The route starts on Rt. 174 and goes up Coon Hill Road then north on Rose Hill Road to the finish. A motion was made by Councilor Lathrop to grant the request of Mr. Searing. This request was seconded by Councilor O'Hara.

It was also suggested that we purchase as much as we can locally. Councilor Scanlon thanked Don MacLachlan for his efforts on writing the truck numbers on the vouchers.

### **Items from the Floor:**

Bernie Montgomery, town resident, is very concerned about the report that Councilor O'Hara spoke of is not submitted to the state yet. It is his understanding that 2010 and 2011 are not in either. As a taxpayer, he is not happy and feels that an audit should be done.

Mary Jo Paul, town resident, stated that as a taxpayer she would like her tax dollars to pay for an audit so that the books are up to date.

The Board members would like to work with Tracie Barnes, Accountant, to get the books up to date

### **Motions to Adjourn to Executive Session:**

A request was made by Jim Gascon, Town Attorney to go into Executive Session. A motion was made by Councilor Lathrop and seconded by Councilor Scanlon to enter into Executive Session at 8:05. The purpose of this session is to discuss a personnel issue at the Highway Department.
