There will be a check coming from Auctions International for items that were sold, that will be put back into the Fund Balance Account. Councilor Hunt made a motion seconded by Councilor Stevens to allow the Budget Transfer of \$40,000 from the Fund Balance Account into one of the Highway Accounts.

WORKSHOP SESSION:

<u>Permit Fees:</u> John Houser, Codes Officer, and Karen Cotter, Planning & Zoning Secretary, are working on the Permit Fees. This is a busy time of year for both offices, so they will let the Board know when they are ready to present new fee amounts.

<u>Fund Balances:</u> Lori Petrocci, Bookkeeper, typed up sheets with the Account Balances as of December 31, 2017 with amounts the Comptroller recommends keeping in the Fund Balance. There was also a Reserves sheet with an ending date of December 31, 2017. The Board will discuss these balances more at Budget Time and when all the members of the Board are here. Supervisor Pollard did mention that if you put money into a Reserve Account, that money has to be used for what the Account is allocated for.

<u>Storm Water Update – John Houser:</u> The Codes Officer, John Houser, gave a brief presentation on the Sage Meadows Stormwater Management Area. The Town needs permission to discharge Storm Water under a General Permit. He also stated that there are fourteen (14) Storm Water Management areas in the Town of Marcellus.

Highway Town/Village IMA (Added Item): John Curtin, Village Mayor, thought about having an Intermunicipal Agreement (IMA) between the Town and Village for the Highway Departments. The two Departments have worked together on some projects and this is a general IMA so that every time a project comes up, a new IMA doesn't have to be drawn up. The IMA states that the Highway Superintendent receive authorization from the Town Supervisor to make a positive or negative determination, on a case by case basis, to offer assistance in the form of Town personnel, materials and/or equipment. Jim Gascon, Town Attorney, suggested to the Board that they give Don MacLachlan, Highway Superintendent, leeway on projects that the Town Highway would help on. This would be a Board policy. This will be on the September 5, 2018 agenda for further discussion.

<u>Fire Department:</u> Jim Rossiter, Brian Haney and Chuck Paul, all from the Fire Department, were here to answer questions the Board had regarding their proposed 2019 Budget. A question was brought up as to how much the Fire Department receives from Glider Oil, they said \$500.00 month. Supervisor Pollard mentioned that maybe some of the paperwork that is done at the Fire Department could be done here at the Town Hall. This is something that the Fire Department and the Town Board need to think about. Supervisor Pollard asked if they would like to come back to further discuss their proposed 2019 Budget and the possibility of the Town Office helping out. The Fire Department will be added to the September 5, 2018 agenda.

<u>Items from the Floor:</u> Don MacLachlan, Highway Superintendent, stated that he applied for a Grant to help out with the drainage issues in the Knolls, by Candlewick. We are waiting to hear from that.

Supervisor Pollard stated that they would like to have an Attorney/Client meeting when the Workshop Session is adjourned.
