OLD BUSINESS:

Drainage: Supervisor Pollard and John Houser, Codes Officer, received information that a man named Doug Fisher, from Soil and Water, can help out with the drainage issues in the county. The Town does not have a permanent solution regarding the drainage issues around the Town and working with Mr. Fisher and Joe Durand, Engineer from TDK, hopefully a solution will be found.

Councilor Cusick made a motion seconded by Councilor Stevens to set a meeting date of March 20, 2019 at 6:30 pm for the residents to come and hear more about the drainage issues and solutions for the Candlewick residents. A letter, map and easement will go out by the end of the week to the Candlewick residents informing them of the upcoming meeting.

Projector/Screen: John Cusick suggested a big screen television (55") and a laptop that should help with the showing of all documents at meetings (Planning/Zoning Board and Town Board). Supervisor Pollard has talked with Pete Knowles, the IT man and he stated that he could hook up Wi-Fi into this building. More information will come along on the projector/screen project.

<u>Vault Door:</u> Supervisor Pollard had a card from a company called TEAM Services, Inc. regarding the cleaning of the vault. They are located in New Jersey, but work all around the Northeast. Someone is coming tomorrow (Thursday, February 7, 2019) to look at the vault and assess what needs to be done. They will then send an estimate as to the cost.

<u>Stormwater</u>: Councilor Hunt made a motion seconded by Councilor Sayre to accept the changes to the Memorandum of Agreement for the Central New York Stormwater Coalition that John Houser, Codes Officer, gave to Supervisor Pollard. The changes have to do with representatives at meetings and the majority and supermajority voting. A copy of the Memorandum of Agreement for the Central New York Stormwater Coalition is available at the Codes Office and the Town Clerk's Office.

NEW BUSINESS:

Fire Department: Councilor Hunt made a motion seconded by Councilor Sayre to authorize Supervisor Pollard to sign the Fire Department Contract with the suggested changes in Sections 2 and 4. The first change was in Section 2, stating that the balance of said building maintenance reserve fund shall not exceed \$75,000 (formerly it was \$50,000). The second change is in section 4, where the Department shall notify the town of any change in expense line item from which funds were originally budged, but in no event shall the Department expend funds in excess of \$5,000 (formerly \$500) outside the line item budget without Town approval.

The Fire Department also wanted to change the audit to every other year to present to the Town. After much discussion, the Town wanted to keep the audit annual for 2019. This will be revisited for the 2020 contract with the Fire Department.

Request from McClurg Remodeling: Councilor Stevens made a motion seconded by Councilor Cusick to approve the request from McClurg Remodeling about the reservation in the Park. McClurg Remodeling is pairing up the non-profit group "Sleep in Heavenly Peace" on June 15th. They would like to use one of the larger parking lots in the Park to build 101 bunk beds so that no kids sleep on a floor. Phil Coccia, Recreation Director, is aware of this and stated that they would be renting the Creek Hollow and Stone Mill Pavilions. There is no rain date for this event. Jim Rossiter, Fire Chief, stated that if it is raining that day, they could use the Fire Department. The trucks could be out in the rain. Phil Coccia is meeting with McClurg's again on March 19, 2019.

Community Grant Resolution (added item):

Town of Marcellus Town Board Resolution IN FAVOR OF COMMUNITY GRANT APPLICATION

March 6, 2019

The following resolution was made by Councilor Cusick, and seconded by Councilor Stevens, at the Regular Meeting of the Town Board of the Town of Marcellus on March 6, 2019.

WHEREAS, the County of Onondaga Community Development Division has solicited project proposals for the 2019 Community Development Block Grant funding cycle by letter dated January 30, 2019, a copy of which is incorporated herein in its entirety by reference herein; and

WHEREAS, the primary objective of the program is to benefit low income people in the County; and

WHEREAS, Category D "Low Income Benefit" specifically indicates any project that benefits either the elderly or handicapped persons qualifies for potential funding; and

WHEREAS, the renovation of existing restrooms for handicapped accessibility in parks or other facilities further qualifies for potential funding; and

WHEREAS, the Town Parks and Recreation Department has identified a park restroom that requires renovation to meet elderly and handicapped persons needs; and

WHEREAS, the Town desires input from the general public as to potential additional projects that may meet the criteria set forth for the said Community Development Grant; and

WHEREAS, the terms of the Grant require that a public hearing be held; and

NOW, THEREFORE, it is

RESOLVED, that the Town of Marcellus through action of this Board does authorize and approve the pursuit of a grant from the Onondaga County Community Development Division, for an amount not to exceed \$20,000, of which the Town will contribute approximately 25%, and that said Grant will be used to benefit senior citizens and/or handicapped persons within the Town of Marcellus; and it is further

RESOVLED, the Town will have a public hearing for the purpose of reviewing a proposal for the renovation of a park bathroom to accommodate elderly and handicapped persons, to develop a five (5) year plan, to approve a local Town contribution for the project and for any and all additional proposals the public desires to present for the Community Development Grant; and it is further

RESOLVED, the public hearing to consider the above proposal and all other proposals will be held at the Town Hall on April 3, 2019 at 7:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested will be heard.
