Main Street for a price of \$229,000.

OLD BUSINESS

Comprehensive Plan Consultants: Dan Kwasnowski, from the County, reached out to Supervisor Pollard regarding the two proposals we received regarding the Comprehensive Plan. The proposals are from Bergmann Architects, Engineers, Planners and the other one is from EDR (Environmental Design & Research). Mr. Kwasnowski would like to meet with Supervisor Pollard, Jerry Wickett (from the Planning/Zoning Board) and anyone else that would be available to review the proposals more in-depth. Supervisor Pollard will contact Mr. Kwasnowski to set up a meeting. No action taken at this time.

<u>Cannabis Informational Meeting:</u> The board was given a draft for a display ad to be put in the paper regarding Marijuana Regulation and Tax Act. After a few changes, the ad will be sent to the paper tomorrow. The meeting will be on Thursday, September 30, 2021 at 7:00 pm. this will take place at the Marcellus Fire Department on Slate Hill Road. This informational meeting will be open to all Residents for their input on the Marijuana Regulations. There will be an attorney from Costello, Cooney and Fearon there to answer any questions/concerns. Comments will be taken through the regular mail or by emailing Supervisor Pollard.

NEW BUSINESS

<u>Challenge Island Agreement:</u> Councilor Stevens made a motion seconded by Councilor Sayre to Authorize Supervisor Pollard to sign the Agreement with Challenge Island (once the Town receives Proof of Insurance naming the Town of Marcellus as a Certificate Holder). Challenge Island will offer two (2) classes for the Fall of 2021.

Challenge Island Jr. Wednesdays – three (3) four-week series in October, November and December from 3:00-4:00 pm. This is for children ages 4-6. The fee for each four-week series is \$60.00 per child, \$50.00 per student for Challenge Island and \$10.00 per student for the Town of Marcellus.

Parent's Night Out/Kid's Pizza 'n' Steam Night: Challenge Island will offer six (6) two-hour Friday Night Programs for kids ages 7-12 in October, November and December from 6:00 pm - 8:00 pm. The dates are 10/1, 10/15, 11/5, 11/19, 12/3 and 12/17. The fee for this is \$40.00 per child, \$30.00 per student for Challenge Island and \$10.00 per student for the Town of Marcellus.

<u>Marshfield Farms – Farmland Protection Implementation Grant Support:</u> Councilor Hoey made a motion seconded by Councilor Stevens to support the Marshfield Farms owners to prepare an application to the New York State Department of Agriculture and Market's Farmland Protection Implementation Grant program. This program funds the protection of viable agricultural land through the use of voluntary conservation easements. Marshfield Farms

includes approximately 292 acres spanning both the Town of Skaneateles and the Town of Marcellus. The parcel that are in the Town of Marcellus are:

TOWN OF MARCELLUS TOWN BOARD RESOLUTION

September 15, 2021

TOWN OF MARCELLUS LOCAL LAW NO. A OF THE YEAR 2021

("A Local Law Overriding the Tax Levy Limit Established In General, Municipal Law §3-C in the Town of Marcellus")

Councilor Stevens introduced proposed Local Law No A of the year 2021, relating to the ability of the Town of Marcellus to override the limit on the amount of real property taxes that may be levied by the Town of Marcellus pursuant to General Municipal Law §3-C, and to allow the Town of Marcellus to adopt a Town Budget for the fiscal year 2022 in excess of the "tax levy limit," and made the following motion, which was seconded by Councilor Hoey.

<u>WHEREAS</u>, Volume 6 N.Y.C.R.R., Section 617 of the regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

<u>WHEREAS</u>, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Marcellus, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and

<u>WHEREAS</u>, the adoption of said Local Law is an Unlisted action for purposes of environmental review under SEQRA; and

<u>WHEREAS</u>, the Town Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

<u>WHEREAS</u>, the said EAF has been prepared and has been reviewed by the Town Board; and

<u>WHEREAS</u>, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria,

NOW, THEREFORE, it is

RESOLVED AND DETERMINED the Town Board has determined this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQRA; and it is further;

RESOLVED AND DETERMINED that the Town Board conduct a Public Hearing as to the enactment of Proposed Local Law No. A of the year 2021 at the Marcellus Town Offices located at 24 East Main Street in said Town on October 20, 2021 at 6:00 pm, or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard.
