OLD BUSINESS:

Fire Alarm Contract: The Fire Alarm Contract from Siemens will be tabled until the January 19. 2022. The councilors would like a chance to look over the contract.

Fire Department Contract: Councilor Hoey made a motion seconded by Councilor Hood authorizing Supervisor Pollard to sign the Fire Department Contract for 2022. The amount the Town will provide to the Marcellus Fire Department is \$329,390. The Fire Department will provide fire protection and rescue services capable of properly responding to emergencies in the Town of Marcellus.

MAVES Contract: Councilor Hoey made a motion seconded by Councilor Hood authorizing Supervisor Pollard to sign the contract with MAVES for 2022. The cost the Town will provide MAVES is \$311,000. MAVES shall provide emergency medical ambulance services for all persons in the limits of the Town of Marcellus, including the Village. Ayes – Pollard, Hoey and Hood Carried

SAM'S Grant: Supervisor Pollard made a motion seconded by Councilor Hood to authorize Supervisor Pollard to sign the SAM Grant to resurface the tennis and basketball courts and put up an ADA playground in Marcellus Park in the area of the Grove Pavilion. The Town will contribute up to \$14,000 towards the resurfacing of the tennis and basketball courts and will contribute up to \$18,000 towards the Grove Playground that will meet the ADA requirements. The "Friends of the Park" will also contribute an in-kind donation of \$5,000 towards the playground.

This undertaking of the Tax Collector is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Tax Collector; and

This undertaking of the Town Justices is further conditioned that they will well and truly keep, pay over and account for all moneys and property coming into their hands as such Town Justices; and

This undertaking of the Superintendent of Highways is further conditioned that he will well and truly keep, pay over and account for all moneys and property coming into his hands as such Superintendent of Highways; and

This undertaking of the Deputy Town Supervisor is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Deputy Town Supervisor; and

This undertaking of the Court Clerk is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Court clerk; and

This undertaking of the Bookkeeper is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Bookkeeper; and

This undertaking of the Deputy Town/Tax Clerk is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Deputy Town/Tax Clerk; and This undertaking of the Planning/Zoning Secretary and Codes Secretary is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Planning/Zoning Secretary and Codes Secretary; and

This undertaking of the Recreation Attendant is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Recreation Attendant; and

The town does and shall maintain insurance coverage, presently with Selective Insurance, in the sum of \$450,000.00 for the Tax Collector, \$50,000.00 for Supervisor , \$25,000.00 each for the Town Justices, \$25,000.00 for Highway Superintendent, \$25,000.00 for Town Clerk and \$25,000 for the Deputy Town Supervisor, \$25,000.00 each for the Court Clerk and the Bookkeeper and \$25,000 for the Deputy Town/Tax Clerk, \$25,000 for the Planning/Zoning and Codes Secretary and \$25,000 for the Recreation Attendant to indemnify the Town against losses through the failure of the officers, clerks and employees covered thereunder faithfully to perform their duties or to account properly for all monies or property received by virtue of their positions or employment, and through fraudulent or dishonest acts committed by the officer, clerks and employees covered thereunder.

<u>Audit of Books</u>: Each year the Board will take a department and do an internal Audit of the Books. The Court Office is the one that we have to send a resolution to the New York State Courts. Due to the fact that two board members are absent, Supervisor Pollard has offered to audit the Court's Books. The other departments will be assigned a Board Member at the January 19, 2022 meeting.

<u>Annual Mandatory Safety Training</u>: Supervisor Pollard received an email that the Town Employees will have to do a mandatory safety training. Supervisor Pollard will have everyone take the training virtually, as there as many time slots available.

Comprehensive Plan: Supervisor Pollard explained the Comprehensive Plan to Councilor Hood. She explained that we have one that is very outdated. Councilor Hoey made a motion seconded by Councilor Hood authorizing Supervisor Pollard to sign the Agreement with Bergmann Associates to help the Town update the Comprehensive Plan. Ayes – Pollard, Hoey and Hood Carried

<u>Selling of Town Hall:</u> Supervisor Pollard stated that we have not received a petition from the Permissive Referendum for the selling of the Town Hall. She asked what the next steps are to move forward. Jim Gascon, Town Attorney, stated that the realtor is starting Phase 1. An abstract has been ordered. Don MacLachlan, Highway Superintendent, stated that Jeff Schultz, a surveyor, would like to come and put the stakes in on where the Town Hall property lines are.

Discussion

Supervisor Pollard heard from a resident on Limeledge Road. His wife had a close call with a truck from Hanson. He asked about reducing the speed on Limeledge. Supervisor Pollard explained that he would have to get a petition and with the Boards approval can send it to the proper channels.

A resident sent in a letter and pictures about the water issues by Deer Path and Browsing Lanes. Don MacLachlan, Highway Superintendent, stated that the Town can't do anything more for this issue.

Supervisor Pollard indicated that we are receiving another grant from Soil and Water. This won't be available until 2023.

Phil Coccia, Recreation Director, mentioned to the Board that "Teal there's a Cure" approached the Recreation Department regarding the use of the Park for their July 4th, run. Mr. Coccia, will Have Sandy Elsey, contact them to receive in writing about what parts of the Park they would like to use.

Bill Southern, Sheehan Road, stated that there is already a Community Development Grant for the Grove Playground. The Town will look into this.

<u>Adjournment:</u> Councilor Hoey made a motion seconded by Councilor Hood to adjourn the Town Board Meeting at 7:30pm.
