WHEREAS, in accordance with the provisions of Section 272-a of New York State Town Law, the Town Board established an advisory Steering Committee to review the Town's existing Comprehensive Plan, adopted in 2001 ("2001 Plan"), and to make recommendations for updates to that Plan for Town Board consideration and adoption; and

WHEREAS, the Comprehensive Plan Steering Committee was comprised of members of the Planning Board, Zoning Board of Appeals, and other community members who represented a broad range of community perspectives; and

WHEREAS, the Steering Committee, supported by Colliers Engineering and Design, reviewed the 2001 Plan and developed a Comprehensive Plan Update setting forth a vision for the Town and identifying goals, objectives and action items regarding rural character preservation; natural resource protection; residential living; support of the local economy; and enhancement of the Town's community resources; and

WHEREAS, throughout the process, the Steering Committee engaged residents of the Town of Marcellus in the planning process by means of a public workshop, a public open house, a public hearing, and information posted on the Town website;

NOW, THEREFORE, BE IT RESOLVED, that the Draft Comprehensive Plan, dated August 8, 2024, as prepared by Colliers Engineering and Design is hereby endorsed by the Comprehensive Plan Steering Committee and is hereby submitted to the Town of Marcellus Town Board for their full consideration and adoption.

Good afternoon Supervisor Stevens,

I hope this finds you well and enjoying summer! Today kicked off week 5 of 8 weeks of Summer Nature Day Camp here at Baltimore Woods Nature Center and the kids are just having a wonderful time out on the preserve and enjoying the new trails and spaces across the new 90 acres we added in 2022. We continue to be very grateful for the support of the Town of Marcellus when we applied to the NYS Parks Environmental Projection Fund Grant that helped us secure the funding needed to grow this beloved preserve by 50% and protect it through a conservation easement in perpetuity.

We are working hard to advance the next phase of our vision for the future to better serve the Marcellus and broader Central New York community and accomodate what we expect to even higher annual growth after we open new trails later in August (an invitation to a trail opening will be in you mailbox soon!) by applying to the NYS Parks ZBGA Capital Grant Opportunity due on August 23 to expand the John Weeks Interpretive Center and main parking lot for Baltimore Woods. In each of the past two years, we have already seen a 30% increase in visitation and the limitations of the current capacity of our building and parking lot have meant that we are turning people and programs away each year - including dozens of field trip requests. We want to be able to provide hikers and recreation seekers opportunities to connect with this unique preserve, to view and engage with our Natural Heritage Collections in and around the Interpretive Center, and open up even more opportunities for everyone to get out and explore nature no matter their age or ability (the new parking lot and building design will bring some much-needed upgrades to accessibility).

I'm hoping you might have time to meet so I can share the project design and goals with you, or even give you a tour of the spaces! I hope you might consider continuing your support for our organization and mission to connect people and nature through wisdom and wonder through a letter of support for our grant application as we plan out what our next 60 years will look like.
