A Budget Meeting of the Town Board of the Town of Marcellus, County of Onondaga, State of New York was held on Wednesday, September 3, 2025, in the Town Hall, 22 E. Main Street, Marcellus, New York. Those present were:

Also Present: Lori Petrocci, Budget Officer, Donald MacLachlan, Recreation Director and Michele Norstad, Recreation Attendant.

Donald MacLachlan gave an overview of the Cemetery Budget stating that the Park employees along with the Highway department can take care of repairing the cemetery stones saving the taxpayers money, while still having a company come in to clean them.

The decision was made to use Option 2 for the Recreation Attendant schedule. The Board stated that the attendants' hours will need to be here some mornings when the building opens and then again in the afternoon, until the building closes. These set hours will be publicized to inform the public.

The Board decided to adjust the Fire Department Truck Reserve from \$100,000 to \$80,000, for the purchase of a Ladder Truck. The Board stated that the Fire Department should go to the taxpayers for a vote as to whether or not approval of a new fire truck is granted.

The Board also questioned, as to where the money goes from the propane tank income.

The Board increased the LOSAP Service Awards budget line by \$7,600 to compensate for the possible increase should the taxpayers approve the increase from \$700 per firefighter to \$1,200.

The meeting concluded at 6:15 p.m.

Two companies have submitted bids for the job; P. Black Glass company for \$31,650.00 and Kelly Bros for \$60,572.05. The bid was awarded to P. Black Glass co. for the total cost of \$31,650.00. The Fire Department will pay for the doors out of the building reserve account.

Councilor Clarke made a motion seconded by Councilor Berwald to approve the proposal from P. Black Co. and authorize Supervisor Stevens to sign the contract.

<u>DEC Public Fishing Rights:</u> Dan Bishop, DEC representative was present at the meeting. It does not change anything regarding the property unless the property is sold then the DEC will maintain ownership of the easement and the right of fishing. Marcellus School District and the Village of Marcellus will also be selling easements rights to DEC. This topic has been tabled for further discussion.

New Business:

Reappointing Town Assessor: Jeffrey Lowe has been reappointed as the Town of Marcellus Assessor for a term of six-years commencing on October 1, 2025, through September 30, 2031.

LL B-2025 Tax Levy Override Introductory Resolution:

TOWN OF MARCELLUS TOWN BOARD RESOLUTION September 17, 2025 TOWN OF MARCELLUS LOCAL LAW NO. B OF 2025

("A Local Law Overriding the Tax Levy Limit Established in General Municipal Law §3-c in the Town of Marcellus")

Supervisor Stevens introduced proposed Local Law No. B-2025, relating to the ability of the Town of Marcellus to override the limit on the amount of real property taxes that may be levied by the Town of Marcellus pursuant to General Municipal Law §3-c, and to allow the Town of Marcellus to adopt a Town budget for the fiscal year 2026 in excess of the "tax levy limit," if necessary, and made the following motion, which was seconded by Councilor Clarke:

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Marcellus, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and

WHEREAS, the adoption of said Local Law is an unlisted action for purposes of environmental review under SEQR; and

WHEREAS, the Town Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Town Board; and

WHEREAS, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that the enactment of proposed Local Law No. B-2025 is an unlisted action, there are no other involved agencies and this Board shall act as lead agency in this matter for purposes of SEQR review; and it is further

RESOLVED AND DETERMINED, the Town Board has determined this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQR; and it is further

RESOLVED AND DETERMINED, that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. B-2025 at the Town Hall located at 22 East Main Street, Marcellus, New York on October 15, 2025, at 6:30 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard; and it is further

RESOLVED AND DETERMINED, that notice of said public hearing shall be provided at least five (5) days prior to the date of said public hearing in a newspaper of general circulation within the Town of Marcellus and to any affected municipalities described above.

HI Laurie.

We were meeting yesterday with Mike Ossit and Village staff to look at areas of erosion concern along Ninemile Creek within the Town Park. The topic of Public Fishing Rights (PFR) easements came up. Would the Town be interested in selling the DEC PFR easements on the two parcels they own along Ninemile?.

It would be the ballfield area (one bank of the creek) and the TownPark (both banks). The total compensation would be approximately \$12,200 pending verification by our Real Property staff. The easement gets added to the property deed so it is permanent and the DEC covers all the closing costs.

Is that something the Town would be open to ?. I know the Town currently allows angling there, but this would guarantee it in the future and also provide some revenue at the same time.

WITNESSETH, that the Grantor, in consideration of TWO THOUSAND, TWO HUNDRED and NO/100 DOLLARS (\$2,200.00), lawful money of the United States paid by the Grantees, does hereby grant and release to the Grantees, their successors and assigns forever,

THE SOLE AND EXCLUSIVE RIGHT, PRIVILEGE AND EASEMENT of occupying and using at all times hereafter as a fishing ground, and for no other purpose, for the use and benefit of the public:

ALL THAT PIECE OR PARCEL OF LAND situate in the Town of Smithville, County of Chenango, and State of New York, lying within the bed of Genegantslet Creek, and within thirty-three (33) feet landward of the Right bank thereof, bounded upstream by New York

State Route 41, and downstream by lands now or formerly of Stuart L. Mohr, Sr., and Frances B. Mohr (Liber 789 Cp 430).

BEING a portion of premises conveyed to the Grantor by deed from Elsie I. Skillman, as Administratrix of the Estate of Dorothy M. Adams, deceased, dated August 12, 1978, and recorded in the Chenango County Clerk's Office on August 14, 1978, in Liber 583 of Deeds at Page 894.

RESERVING to the Grantor, its successors and assigns, the right to access, maintain, replace and utilize the two dry hydrants located within the bed and westerly bank of the Genegantslet Creek as needed to take water from the Creek for fire department purposes, as well as the right to take water from the creek for the stated purposes.

SUBJECT to any easements or rights-of-way of record.

The terms "Right" or "Left" bank, as used herein, refer to "Right" or "Left" as one faces downstream. The distances landward from the bank begin at ordinary high water mark of the stream.

It is mutually covenanted and agreed by and between the parties hereto that the occupation and use of the parcel above described as a fishing ground for the use and benefit of the public is understood to include the following rights, privileges and easements:

- 1. To persons legally entitled to do so, to catch and take fish from said stream by legal means and for this purpose to travel said stream and to utilize the lands above described for the full enjoyment of this easement.
- 2. At the discretion of Grantees to improve the said stream by the installation and maintenance of current deflectors and retarders and any other means for the purpose of fostering and improving fishing therein.
- 3. At the discretion of Grantees to protect the lands above described from erosion by mechanical means or by the planting of trees, plants or shrubs and by the means to provide shade for the protection of the fish in said stream.
- 4. To post signs and posters along the land, including on trees, as deemed necessary and suitable by the Grantees.
- 5. In case the course of the stream of water located on the strip of land above described shall be changed by natural or artificial means, the easement shall follow the course of the stream as changed.
- 6. No right or title of either party hereto, other than as hereby agreed to be conveyed, is to be affected by the execution or acceptance of this easement.

- 7. The Grantor reserves to itself, its heirs and assigns, the right to the use of said land, including the right of fishery in the stream, provided that such use is not inconsistent with the use of the same as a public fishing ground and with the easement hereby granted, and further reserves the right to use the water in the stream as if this grant had not been made.
- 8. The rights, privileges and easements hereby granted are to be used by the Grantees for the benefit of the public, subject to and in accordance with the provisions of the Environmental Conservation Law of the State of New York as now enacted or hereafter amended or enacted and the rules and regulations of the Department of Environmental Conservation of the State of New York as now in force or hereafter adopted.
- 9. The Grantor retains the right to post signs against trespassing on the Easement areas as described herein, provided however, that the content of any such sign shall not work to discourage legitimate access for purposes contemplated by this deed of easement and the content of such signs shall be substantially as follows: "NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION, PUBLIC FISHING EASEMENT, FISHING PERMITTED, ENTRY FOR ANY OTHER PURPOSE STRICTLY PROHIBITED:"
- 10. Any subsequent conveyance by Grantor shall be subject to this EASEMENT and any deed or other instrument evidencing or effecting such conveyance shall contain language substantially as follows: "This deed is subject to a fishing rights easement which runs with the land and which was granted to The People of the State of New York by instrument dated_____, and recorded in the office of the Clerk of _____ County at Liber___ of Deeds at page ____." The failure to include such language in any deed or instrument shall not, however, affect the validity or applicability of this EASEMENT to lands above described.

These covenants are to run with the land and are to apply to and bind the grantees, successors and assigns of the Grantor.

TO-HAVE AND TO HOLD the above granted rights unto the Grantees, their successors and assigns forever.



Chapter 119. Games of Chance

[HISTORY: Adopted by the Town Board of the Town of Marcellus 3-3-1979 by L.L. No. 1-1979; amended in its entirety at time of adoption of Code (see Ch. 1, General Provisions, Art. I). Subsequent amendments noted where applicable.]

§ 119-1. Authorization; license required.

It shall be lawful for any authorized organization, upon obtaining a license as provided in Article 9-A of the General Municipal Law, to conduct games of chance within the Town of Marcellus, subject to the provisions of this chapter, Article 9-A of the General Municipal Law and the New York State Gaming Commission.

§ 119-2. Sundays; holidays;

The conduct of games of chance on Sunday is permitted only when it is specifically provided for in the license issued, and then only between the hours of 12:00 noon and 12:00 midnight. No games of chance, however, shall be conducted on Easter Sunday or Christmas Day.

§ 119-3. Enforcement.

The Town Supervisor of the Town of Marcellus shall exercise control over and supervision of all games of chance.

§ 119-4. Summary license applications.

Pursuant to General Municipal Law § 190, Subdivision 3, certain "repeat" authorized organizations may submit summary applications.

§ 119-5. When effective.

This amended chapter shall be effective 30 days following enactment.

General Municipal Law Article 9-A Section 188-A

Powers and duties of the board

The board shall have the power and it shall be its duty to:

1.

Supervise the administration of the games of chance licensing law and to adopt, amend and repeal rules and regulations governing the issuance and amendment of licenses thereunder and the conducting of games under such licenses, which rules and regulations shall have the force and effect of law and shall be binding upon all municipalities issuing licenses, and upon licensees of the board, to the end that such licenses shall be issued to qualified licensees only, and that said games shall be fairly and properly conducted for the purposes and in the manner of the said games of chance licensing law prescribed and to prevent the games of chance thereby authorized to be conducted from being conducted for commercial purposes or purposes other than those therein authorized, participated in by criminal or other undesirable elements and the funds derived from the games being diverted from the purposes authorized, and to provide uniformity in the administration of said law throughout the state, the board shall prescribe forms of application for licenses, licensees, amendment of licenses, reports of the conduct of games and other matters incident to the administration of such law.

2.

Conduct, anywhere in the state, investigations of the administration, enforcement and potential or actual violations of the games of chance licensing law and of the rules and regulations of the board.

3.

Reveiw [sic] all determinations and actions of the clerk or department in issuing an initial license and it may review the issuance of subsequent licenses and, after hearing, revoke those licenses which do not in all respects meet the requirements of this article and the rules and regulations of the board.

4.

Suspend or revoke a license, after hearing, for any violation of the provisions of this article or the rules and regulations of the board.

5.

Hear appeals from the determinations and action of the clerk, department or officer in connection with the refusing to issue licenses, the suspension and revocation of licenses and the imposition of fines in the manner prescribed by law and the action and determination of the

board upon any such appeal shall be binding upon the clerk, department or officer and all parties thereto.

6.

Carry on continuous study of the operation of the games of chance licensing law to ascertain from time to time defects therein jeopardizing or threatening to jeopardize the purposes of this article, and to formulate and recommend changes in such law and in other laws of the state which the board may determine to be necessary for the realization of such purposes, and to the same end to make a continuous study of the operation and administration of similar laws which may be in effect in other states of the United States.

7.

Supervise the disposition of all funds derived from the conduct of games of chance by authorized organizations not currently licensed to conduct such games.

8.

Issue an identification number to an applicant authorized organization if it shall determine that the applicant satisfies the requirements of the games of chance licensing law and the rules and regulations of the board.

9.

The board shall have the power to approve and establish a standard set of games of chance equipment and shall by its rules and regulations prescribe the manner in which such equipment is to be reproduced and distributed to licensed authorized organizations. The sale or distribution to a licensed authorized organization of any equipment other than that contained in the standard set of games of chance equipment shall constitute a violation of this section.
