Knox Box: A knox box is a secure box placed on a building that allows first responders to access the buildings during an emergency. The Town will be purchasing three knox boxes at a total cost of \$1,513,00 including shipping and handling. Two will be for Marcellus Park and one for the Town Highway Garage.

Councilor Hood made a motion seconded by Councilor Clarke to declare Knox Company as a sole source and purchase three knoxbox 3200 model #3261, one for the welcome center, park maintenance building and highway garage.

Marcellus Cross Country Invitational: The Marcellus Cross Country team would like to host their 2nd cross country invitational at Marcellus Park, October 18, 2025. Last year the event brought 25 schools and over 830 runners and hundreds of spectators. They are requesting three pavilions; Annex, Stone Mill and Creek Hollow along with the Welcome Center. The event will start at 9:00am and end at 1:30pm. There will be a Pumpkin Run for staff, students and alumni of Marcellus. They hope to have more inclusion of local businesses to market themselves with the exception of food. After some discussion it was decided the Welcome Center will not be open to this event due to cleats possibly damaging carpet and floors. The school will not be charged a fee by the Town of Marcellus to host the event but must bring in portable toilets as they did last year.

Councilor Hoey made a motion seconded by Councilor Hood to approve the 2nd cross country invitational at Marcellus Park on October 18, 2025.

Park Pavilion Fees for 2025: The Town Board modified the surcharge fees for pavilion rentals. The pavilion fees remain the same. The new surcharge applies when capacity is exceeded. The modified terms and amounts are as follows; 1-25 ppl \$25.00, 26-50 ppl \$50.00, 51-75 ppl \$75.00, 76-100 ppl \$100.00 and 101 ppl and over is \$150.00. Also, part of the modification was to charge an additional \$100.00 to any party that does not obey the carry-in and carry-out policy and pavilions must be paid in full within 14 days of reservation. The Town Board decided Marcellus non-profit organizations are not subject to pavilion rental fees.

Vicky Servello addressed the Town Board with concerns regarding Canadian Wildlife and NYS DEC putting pesticides in the water. Her concern is that Nine Mile Creek is on the list of water that is being treated. The Great Lakes are regularly treated with lampricides, chemical compounds that effectively kill sea lamprey larvae. After some discussion and reviewing the information and maps provided on the DEC website it was determined that this pesticide is not a threat to the portion of Nine Mile Creek in the Town of Marcellus.

WHEREAS, eligible voters residing in the Town of Marcellus (the "Town") approved a referendum to establish a defined contribution Length of Service Award Program ("LOSAP") for active volunteer firefighter members of the Marcellus Fire Department, effective October 1, 2011, in accordance with Article 11-A of the New York State General Municipal Law ("GML");

WHEREAS, the Town is the LOSAP Sponsor and Program Administrator; and

WHEREAS, GML § 216 authorizes the Town to amend the LOSAP; and

WHEREAS, now, the Town Board of the Town of Marcellus has reviewed a proposal submitted by the Marcellus Fire Department to amend the current service award program for the volunteer firefighters of the Marcellus Fire Department; and

WHEREAS, the Town Board of the Town of Marcellus desires to amend the defined contribution plan as such plan is described in General Municipal Law §218; and

WHEREAS, an active volunteer firefighter currently earns Seven Hundred and No/100 Dollars (\$700.00) for each year of firefighting service rendered; and

WHEREAS, that the entitlement age for each participating firefighter is currently sixty-five (65) years of age; provided, however, if any active volunteer firefighter becomes disabled as described in GML §218(d), the firefighter is entitled to receive his or her service award benefits regardless of age or length of service and such benefits will begin as provided in GML §218(d); and

WHEREAS, the increase permitted by this resolution is consistent with the intent of the LOSAP to recruit, retain and reward active volunteer firefighters.

NOW, THEREFORE BE IT

RESOLVED, that the contribution for each participating active volunteer firefighter shall be One Thousand Two Hundred and No/100 Dollars (\$1200.00) for each qualifying year of firefighting service rendered on and after January 1, 2026; and be it further

RESOLVED, that the entitlement age for each participating firefighter shall be fifty-five (55) years of age; provided, however, if any active volunteer firefighter becomes disabled as described in GML §218(d), the firefighter shall be entitled to receive his or her service award benefits regardless of age or length of service and such benefits shall begin as provided in GML §218(d); and be it further

RESOLVED, that this resolution is subject to a mandatory referendum of qualified voters of the Town of Marcellus and said referendum shall be held on November 4, 2025, at the Town of Marcellus Town Hall, located at 22 East Main Street, Marcellus, New York, in the Town of Marcellus; be it further

RESOLVED, that Proposition Number One to be voted upon at said election shall read as follows:

"SHALL THE ANNUAL CONTRIBUTION OF THE TOWN OF MARCELLUS THE MARCELLUS VOLUNTEER FOR DEPARTMENT LENGTH OF SERVICE AWARDS PROGRAM SEVEN HUNDRED **DOLLARS** (\$700.00) (LOSAP) OF INCREASED BY FIVE HUNDRED DOLLARS (\$500.00) TO THE AMOUNT OF ONE THOUSAND TWO HUNDRED DOLLARS (\$1,200.00), PER QUALIFYING MEMBER, ANNUALLY?"; and be it further

RESOLVED, that Proposition Number Two to be voted upon at said election shall read as follows:

"SHALL THE AGE OF MATURITY OF THE FUNDS FOR THE MARCELLUS VOLUNTEER FIRE DEPARTMENT LENGTH OF SERVICE AWARDS PROGRAM (LOSAP) BE REDUCED FROM 65 YEARS OLD TO 55 YEARS OLD?"; and be it further

RESOLVED, that no later than ten days before said election, this proposition shall be published once in the Marcellus Observer and that a copy thereof shall be posted on the official sign-board of the Town of Marcellus maintained in accordance with New York Town Law §30(6); and be it further

RESOLVED, that the LOSAP shall continue to be administered by the Town and that all other provisions of the LOSAP shall remain the same; and be it further

RESOLVED, that upon such approval at referendum, the Supervisor of the Town of Marcellus shall be and is hereby authorized to execute necessary documents, including documents adopting the program and its related Trust and make such permitted changes in the Program not inconsistent with the terms of Article 11-A of the General Municipal Law and thus enabling referendum as she determines to be appropriate; and be it further

RESOLVED, that notwithstanding anything provided to the contrary, this Resolution shall not be effective unless and until the Town Board receives a certified copy of a Resolution of the Marcellus Fire Department in which the Marcellus Fire Department agrees to perform any and all obligations placed upon it under the terms of this Resolution and/or the General Municipal Law.

Hello from Parks and Recreation! I wanted to update you all on what I have been working on and how 2025 is progressing. Thank you for accommodating my medical leave.

Pavilion reservations have been steadily coming in. Using the new fee structure has been going well, although there are several partial refunds to process.

47 Recreation employees were contacted and so far 14 students, 3 directors and 1 art teacher have notified us that they are returning. We also have 5 new applications to review. April 1st was the deadline given to respond and June 27th the mandatory meeting.

2025 Summer Recreation Programs – All 21 programs with minor adjustments have agreed to repeat minus "Fantastic Fine Motor!". The brochure/pamphlet is near completion and will be hopefully printed by the end of April and uploaded online for registrations as well as circulated within the schools.

Marcellus Central Schools have been contacted to request the use of grounds for our Rec program. I am in the process of utilizing their online (ML Schedules) platform with the help of Mike Free, Mary Pat Tierney and Ryan Riefler. The formal letter request was sent in January.

I am prepping for paperwork submissions to Onondaga County – the first due May $\mathbf{1}^{st}$. This is required for our staff and the summer rec programs.

Senior trips for the Fall are being priced by Lasting Impressions Tours out of Syracuse. I am pricing Letchworth Fall Foliage, Watkins Glenn Boat Tour and a Batavia Downs Motown Holiday Christmas Trip.

Field use reservations have come in from the Optimist Club and Marcellus Softball. Awaiting Lakeshore Baseball.

I have been in contact with the Library to agree to share costs for Moreland the Magician once again and offer Storytime to each grade level within the Rec program.

Yoga (s) and Wrestling were very successful!

I also figured out how to order stamps! Which was good. Everyone has been very helpful.




