Shawn and Courtney Hale, 3577 Maple Rd – Special Permit

A public hearing was held for a 22' X 25' steel carport. The Secretary, Karen Cotter, read the legal notice into the minutes. This will be placed in front of the existing barn to be used to store his vehicle and some equipment. It will not be attached to the barn. Mr. Hale explained that his business has grown and he needs the additional storage. Mr. Christensen wondered if there had been any changes from when the special permit for the barn was originally approved. Mr. Hale explained that he has additional inventory that is stored in the barn including two (2) trucks and one (1) additional car; he has added one (1) new employee and has a portable toilet that is serviced once a week. The Chair, Michelle Bingham asked if anyone would like to speak in favor or opposition to the project and there were none. Jerry Wickett made a motion to close the public hearing and Michelle Bingham seconded. The motion carried with the following vote:

THEREFORE BE IT RESOLVED that said special permit is granted upon the following condition:

1. Applicant must apply for a building permit
