The Zoning Board of Appeals of the Town of Marcellus met in regular session in the Town Hall for the Town of Marcellus, located at 24 E. Main Street, Marcellus, New York, on November 5, 2018 at 7:00pm.

**Patrick and Peggy Morocco, 2527 Falls Rd – Special Permit**

A public hearing was held for a 24' X 40' pole barn. The Secretary, Karen Cotter, read the legal notice into the minutes. Mr. Morocco stated that the barn will be used for personal storage of a boat, two (2) jet skis', tractor, lawnmower and gator. It will be located in the rear of the property and will not be seen from the road. Chris Christensen asked if there were any streams or *\*drainage ditches* near the location and there are none. No business shall be operated from it and it will have no heat or electricity. The Chairperson, Michelle Bingham, asked if anyone would like to speak in favor or opposition to the project and there were none. Jerry Wickett made a motion to close the public hearing and Chris Christensen seconded. The motion carried with the following vote:

Jerry Wickett made a motion to approve the special permit for a 24' X 40' storage barn as a public hearing was held and there was no one present in favor or opposition to the project; the building will have no power or heat and meets all setbacks; it is similar to what is in the neighborhood and will have no adverse effect; it will be for personal storage only and no business shall be operated from there. WHEREAS: The special permit is used for the use specified on the application. Any change of use is subject to approval by the Zoning Board of Appeals: and

WHEREAS: The special permit conforms to side yard, front and rear setbacks.
