## **PUBLIC HEARING – Special Permit**

## 20' x 40' Accessory Building

A public hearing was held for a special permit for a 20' x 40' three (3) sided accessory structure. The secretary Joanna Clarke read the legal notice into the minutes. Vincent Raymond was present to discuss the special permit application. Mr. Raymond stated he would like to build a three (3) sided implement shed to store his tractor. It will be located more than 200 feet from all lot lines and placed against a mound that's covered with flowers and shrubs. The open side will face North.

WHEREAS, the applicant is located in a Residential 1 district: and

**WHEREAS,** there will be no undesirable change in the character of the neighborhood or detriment to nearby properties: and

**WHEREAS,** the use shall be consistent with and subordinate to the principal use and may not be carried on independently of the principal residential use: and

**WHEREAS,** the special permit is used for the use specified on the application. Any change of use is subject to approval by the Zoning Board of Appeals: and

**WHEREAS**, the special permit conforms to side yard, front and rear setbacks.

**THEREFORE, BE IT RESOLVED** that said special permit be granted upon the following condition:

- 1. Applicants must apply for a building permit that grants permission for construction.
- 2. The accessory structure is for personal use only and no business shall be operated from or in it.
