PUBLIC HEARING- Special Permit

Lawrence Minet

3063 RTE 174

20' x 24' Accessory Building

A public hearing was held for a special permit for a 20' x 24' accessory structure. The secretary read the legal notice into the minutes. Larry Minet was present to discuss the special permit application. The following was discussed with Mr. Minet:

- The building will be located in the NW corner of the property.
- Used for personal storage with no electricity.
- Access would be from the footbridge over the creek that divides the property. There is access from the road that will only be used to build the structure.
- The building will have an open lean-to on one side that's 8' x 24' and will face South towards the house.

Chairman Stearns asked if there was anyone who would like to speak in favor or in opposition to the special permit. Jon Bristol of 3922 Rockwell Rd. stated he's in support. Chairman Stearns made a motion to close the public hearing and Jerry Wickett seconded. The motion carried with the following vote:

The building will be for personal use only with no electricity, meets all setbacks, and keeps with the character of the neighborhood. The request of Lawrence Minet for a special permit in a Residential 1 zone to allow him to construct a 20' x 24' accessory building at his residence for 3063 RTE 174, Marietta, NY.

WHEREAS, the special permit is used for the use specified on the application. Any change of use is subject to approval by the Zoning Board of Appeals: and

WHEREAS, the special permit conforms to side yard, front and rear setbacks.

THEREFORE, BE IT RESOLVED that said special permit be granted upon the following condition:

- 1. Applicants must apply for a building permit that grants permission for construction.
- 2. The accessory structure is for personal use only and no business shall be operated from or in it.
