#### **PUBLIC HEARING-Special Permit**

Joshua & Jennifer Swearingen 4186 Summit View Dr.

24' x 24' Accessory Building

A public hearing was held for a special permit for a 24' x 24' accessory building. The secretary read the legal notice into the minutes. Johsua Swearingen was present to discuss the application. Mr. Swearingen stated that they would like to build a pole barn for personal storage with electricity inside only – no outdoor lighting. The building opening would face Summit View Drive. Jerry Wickett advised Mr. Swearingen that an additional road cut facing the pole barn is not allowed.

Chairman Stearns asked if there was anyone who would like to speak in favor or in opposition to the special permit and there was none. Jerry Wickett made a motion to close the public hearing and Ron Schneider seconded. The motion carried with the following vote:

**WHEREAS,** the special permit is used for the use specified on the application. Any change of use is subject to approval by the Zoning Board of Appeals: and

WHEREAS, the special permit conforms to side yard, front and rear setbacks.

**THEREFORE, BE IT RESOLVED** that said special permit be granted upon the following condition:

- 1. Applicants must apply for a building permit that grants permission for construction.
- 2. The accessory structure is for personal use only and no business shall be operated from or in it.
